IMPORTANT INSTRUCTIONS TO BIDDERS

- 1. The bid should be in a SEPARATE ENVELOPE and have typed on the envelope, "Pendery/AJ Jolly Resurfacing," the opening date and time. Campbell County Fiscal Court will not be held responsible for any premature opening or failure to open any bid not properly addressed and identified as stated above
- 2. Bid must be completed, signed in ink and received at Campbell County Fiscal Court, Finance Office, 1098 Monmouth Street, Finance, Newport, KY 41071, in a sealed envelope no later than 9:00 AM; Thursday, February 13, 2020. From 9:00 AM until 10:00 AM on February 13th sealed bids will be accepted at the reception desk, 1098 Monmouth Street, 1st floor. All received bids will be opened and read publicly in the Conference Room 137 of the Campbell County Fiscal Court at 10:00 AM on February 13, 2020.
- 3. Work is at these locations: A.J. Jolly Park, 1505 Racetrack Road, Alexandria, KY 41001; and Pendery Park, 4110 Williams Lane, Melbourne, KY 41059.



- 4. A site visit is recommended and may be scheduled by contacting Facilities Director Mike Braun at 859-743-4145 (cell).
- 5. In the event of a tie, the bid with the earliest time received stamp will be considered the successful bidder. Bidders are invited to attend the public bid opening, and review bid files.
- 6. Work must be completed between February 17 and April 24, 2020. Please contact Facilities Director Mike Braun before beginning work. Work dates may be adjusted to accommodate culvert repair.
- 7. Bidders must be KYTC approved to perform C1, C2, or approved by CCFC Facilities Director, Mike Braun by calling 859-547-1845.
- 8. Bidders are required to submit three qualified references.
- 9. Bid bonds, performance bonds, and payment bonds as prescribed by KRS 45A.430, 435, 440 are required for any bids/proposals that exceed \$99,999. Each bid over \$99,999 must be accompanied by a 5% bid bond of the grand total of the bid. The bid bond of the successful bidder will be retained until a performance bond has been executed and approved, after which the bid bond will be returned. The successful bidder will be required to post a performance bond in the amount of 100% of the bid.
- 10. Contractor is responsible for all permits, licenses, insurance, Hazardous Communication Program (OSHA) and incidentals.
- 11. The successful bidder must have (or obtain) a business license issued by the Occupational License Department of Campbell County.
- 12. Campbell County Fiscal Court reserves the right to reject any or all bids, including without limitations the right to reject any or all nonconforming, non-responsive, incomplete, unbalanced, or conditional bids, to waive formalities, and to reject the bid of any Bidder if Owner (Campbell County Fiscal Court) believes that it would not be in the best interest of the Owner to make an award to that Bidder. Owner also reserves the right to negotiate with the apparent qualified Bidder to such an extent as may be determined by Owner.
- 13. Do not alter bid forms.

- 2. Repave Williams Lane and re-establish 2-3% crown in roadway.
- 3. Paving specifications for all locations:
 - a. Grind butt joints at the transition areas to ensure smooth transition between old and new surface.
 - b. Butt joints to be sealed after paving operations.
 - c. Sweep and remove millings to designated area onsite
 - d. Apply 100% coverage with Trackless tack
 - e. Crown all road surfaces 2-3%
 - f. Leveling course shall be installed to eliminate low spots
 - g. Install 1.5" compacted 448 type 1 asphalt on existing surface.
 - h. Pricing per ton installed shall include all associated costs
 - i. Contractor to remove and reinstall parking bumpers (include pinning down) (Williams Lane Only)
 - j. Contractor responsible to restripe parking lot at Williams Lane only

That I have fully informed myself regarding the accuracy of the statements made in this affidavit.

NOTICE

Any agreement of collusion among bidders or prospective bidders which restrains, tend to restrain, or is reasonably calculated to restrain completion by agreement to bid at a fixed price, or to refrain from bidding or otherwise, is prohibited. The provision of KRS 355.080 and 305.000 which permit the regulation of resale price by contract do not apply to sales to the State, no sales to Local Governments.

Any person who violates any provisions of Kentucky Revised Statue 42.076 shall be guilty of a felony and shall be punished by a fine not less than five thousand dollars nor more than ten thousand dollars, or be imprisoned not less than one year no more than five years, or both such fine and imprisonment. Any firm, Corporation or association which violates any of the provision of KRS 42.076 shall, upon conviction, be fined not less than ten thousand dollars no more than twenty thousand dollars.
