A RESOLUTION OF THE CAMPBELL COUNTY FISCAL COURT ALLOCATING SENIOR CITIZENS TAX FUNDS FOR FY 2022

WHEREAS, the Senior Citizens tax fund allocations for FY 2022 will total \$611,140; and

WHEREAS, agencies serving the 60+ year old population have submitted applications for FY 2022 regarding the services each agency will provide to the residents of Campbell County; and

WHEREAS, the Fiscal Court has reviewed the requests for funding from such agencies.

NOW, THEREFORE, BE IT RESOLVED that the Campbell County Senior Citizens incoming Payroll Tax funds for FY 2022 be allocated to the agencies serving older adults in the amount of \$305,000 in accordance with the attached list of recommendations.

BE IT FURTHER RESOLVED that Campbell County Fiscal Court allocate an additional \$306,140 as follows:

Campbell County Senior Center \$286,140 Senior Citizens' Picnic \$20,000

The funds for these services will be administered by the Campbell County Human Services Department and the funded agencies will submit reports as requested to assess utilization of services by Campbell County residents age 60 and older.
