A RESOLUTION ALLOCATING SENIOR CITIZENS TAX FUNDS FOR FY 2023

WHEREAS, the Senior Citizens tax fund allocations for FY 2023 will total \$587,451 and

WHEREAS, the agencies serving the 60+ year old population have submitted applications for FY 2023 regarding the services each agency will provide to the residents of Campbell County, and

WHEREAS, the Fiscal Court has reviewed the requests for funding from such agencies,

NOW, THEREFORE, BE IT RESOLVED that the Campbell County Senior Citizens incoming Payroll Tax funds for FY 2023 be allocated to the agencies serving older adults in the amount of \$328,800 in accordance with the attached list of recommendations,

NOW, THEREFORE, BE IT FURTHER RESOLVED that Campbell County Fiscal Court allocate an additional **\$258,651** as follows:

Campbell County Senior Center \$236,651 Senior Citizens' Picnic \$22,000

NOW, THEREFORE, BE IT FURTHER RESOLVED that funds for these services will be administered by the Campbell County Human Services Department and the funded agencies will submit reports as requested to assess utilization of services by Campbell County citizens age 60 and older.

The foregoing Resolution was unanimously passed by the Campbell County Fiscal Court on the 4th day of May, 2022.
