### A RESOLUTION ALLOCATING SENIOR CITIZENS PAYROLL TAX FUNDS FOR FISCAL YEAR 2024

**WHEREAS**, the Senior Citizens payroll tax fund allocations for Fiscal Year 2024 will total \$653,000; and

WHEREAS, the agencies serving the 60+ year old population have submitted applications for FY2024 regarding the services each agency will provide to the residents of Campbell County, and

WHEREAS, the Fiscal Court has reviewed the requests for funding from such agencies,

**NOW, THEREFORE, BE IT RESOLVED** that the Campbell County Senior Citizens incoming payroll tax funds for Fiscal Year 2024 be allocated to the agencies serving older adults in the amount of \$313,500 in accordance with the attached list of recommendations,

**NOW, THEREFORE, BE IT FURTHER RESOLVED** that Campbell County Fiscal Court allocate an additional \$339,500 as follows:

Campbell County Senior Center \$314,500 Senior Picnic \$25,000

**NOW, THEREFORE, BE IT FURTHER RESOLVED** that funds for these services will be administered by the Campbell County Human Services Department and the funded agencies will submit reports as requested to assess utilization of services by Campbell County citizens age 60 years and older.
