Welcome & Introductions – Judge/Executive, Steve Pendery

Judge/Executive, Steve Pendery started the Campbell County Mayor's Meeting at 6:00 PM, and asked everyone present to introduce themselves.

Northern Kentucky Drug Strike Force, Scott Hardcorn, Director

The Director of the Northern Kentucky Drug Strike Force, Scott Hardcorn, gave an overview of work being done by the NKDSF. He highlighted the difference between hemp vs. marijuana and explained some background information about the 2018 U.S. Agriculture Improvement Act, more commonly known as the farm bill. He said this bill created a loophole which legalized the manufacturing and sale of highly intoxicating hemp products that are dangerous, contaminated from high levels of toxins, totally unregulated, marketed as "legal hemp" to kids, with no age limits, and sold in places like gas stations, smoke shops, and online. He said every dollar of marijuana tax revenue is associated with \$4.50 in costs. Director Hardcorn also discussed other street drugs such as counterfeit pills, fentanyl, xylazine, and hallucinogens.

Northern Kentucky Water District, Lindsey Rechtin, President/CEO

The President/CEO of the Northern Kentucky Water District, Lindsey Rechtin gave an overview about the district, 2023 accomplishments & impactful developments, and the upcoming work NKWD plans to do.

She explained NKWD is the largest water district in Kentucky and the third largest water provider in Kentucky. She provided stats to give specific examples of NKWDs 2023 accomplishments:

- Produced 9.74 billion gallons of water
- Tested 31,400 parameters
- Replaced 2.77 miles of water main
- Distribution completed 2,464 work orders
- Engineering completed 3,079 underground locate requests
- Customer Service completed 66,582 customer visits
- Tested 6.630 meters
- Posted 47 bids & 16 RFPs
- Account Services participated in 72,172 calls
- Sent 384,260 bills

Ms. Rechtin gave an overview of NKWD current and upcoming projects:

- Memorial Parkway North Reservoir Restoration, estimated to be completed by September 2024
- Lead & Copper Rule which focuses on locating lead pipes
- Newport Ovation to replace nearly 5 miles of water main
- New Subdistrict NKWD was recently awarded federal grant funds to extend water main in their service area

<u>CVG Airport,</u> Seth Cutter, Vice President of Public Affairs

The CVG Airport Vice President of Public Affairs, Seth Cutter gave an overview of Cincinnati/Northern Kentucky International Airport (CVG). Some of the topics he highlighted included: passenger air service information, British Airways success in the first year, air cargo updates, DHL Hub which is the 2nd largest global super hub, Amazon Hub in which Amazon has made a \$1.5 billion investment, FEAM Aero which is a maintenance hangar facility, Epic Academy which is a private aircraft mechanic school, and DHL Hangar.

Mr. Cutter also highlighted some of CVG's projects on the horizon which include: hangar row development, cargo village development, terminal modernization, and concessions updates.

CVG's vision and action toward multi-modal mobility include: development beyond airport, foreign trade zone management, advanced air mobility, SAF & SAF-related infrastructure, connected and autonomous vehicles.

Mr. Cutter discussed CVG's workforce and labor challenges and highlighted that CVG supports 49,000+jobs. CVG's total economic impact includes direct and indirect spending related to airport operation expenditures, capital construction projects, and visitor spending. The growth of CVG's economic impact in the last decade is a result of smart business investments and strategic growth. Mr. Cutter said as a job hub for the region, despite the pandemic, the airport's position as a regional leader will continue.
