# June 5, 2024

The Campbell County Fiscal Court held a regular meeting on Wednesday, June 5, 2024, at 9:00 AM, at the Campbell County Courthouse, 8352 East Main Street, Alexandria, Kentucky. Campbell Media recorded the regular meeting and broadcasted it on the Campbell Media website.

# **Regular Meeting**

Judge/Executive, Steve Pendery called the meeting to order at 9:00 AM.

Judge/Executive, Steve Pendery asked for a moment of silence followed by the Pledge of Allegiance.

# Roll Call

Following the roll call, a quorum was declared present.

# **Minutes**

Judge/Executive, Steve Pendery requested a motion to approve the minutes from the Regular Fiscal Court Meeting on May 15, 2024.

Motion was made to approve the minutes from the Regular Fiscal Court Meeting on May 15, 2024 by Commissioner Geoff Besecker, seconded by Commissioner Brian Painter. All voted "Aye" and the motion passed.

# **Guests**

# Luke Mantle, Road Supervisor, Road Department's Annual Update

Judge/Executive, Steve Pendery introduced Road Supervisor, Luke Mantle who gave an overview of the Road Department and recapped work that has been done over the past year.

Some of the highlights Mr. Mantle covered included: staff, equipment, road responsibly, bridge responsibility, current projects, and projects recently completed.

Mr. Mantle said the Road Department is responsible for: 188 road miles which is an estimated 300 lane miles, vegetation, 124 bridges, drainage, pothole repairs, 1,389 cross culverts under roads, 2,000 tons of asphalt placement, 2-5 miles of ditch lines, concrete slab replacements, slip repairs, winter snow and ice control, 680 signs and 595 posts. He said many of these signs need replaced due to fading, theft, or damage.

Mr. Mantle said vegetation must be kept off the roads to make asphalt last years longer. The Road Department cuts every county roadside 2 -3 times each season. On a daily basis, Mr. Mantle said keeping water of the roads is the departments main focus,

Mr. Mantle thanked Facilities and Fleet Director, Mike Braun, IT Director, Steve Penrod, and Finance/Director Treasurer, Laura Lewis. He also thanked the Fiscal Court for approving the funding needed.

Commissioner Tom Lampe commented that this presentation was one of the most thorough he had ever heard and told Mr. Mantle job well done and thanked him and his department.

Judge/Executive, Steve Pendery thanked Mr. Mantle and his department and said he only typically hears good things about the Road Department, and they save the community money.

# **Old Business**

County Administrator, Matt Elberfeld presented old business.

# Ordinance O-05-24: Second Reading

County Administrator, Matt Elberfeld read the title summary for the second reading of Ordinance O-05-24, "An Ordinance relating to the prohibition of cannabis business operations in Campbell County."

Motion was made to adopt Ordinance O-05-24 by Commissioner Geoff Besecker, seconded by Commissioner Brian Painter.

There was back and forth discussion amongst the Fiscal Court members for clarification.

Judge/Executive, Steve Pendery wanted to make it clear that this Ordinance is for medical use not recreational use and all this Ordinance does is say Campbell County is opting out and that there is not going to be applications made for businesses in Campbell County to produce cannabis for medical purposes.

Police Chief Craig Sorrell said there are very specific state requirements and people need to research and do their due diligence to understand the changes that will take effect in January 2025. He emphasized ignorance of the law will not be an excuse.

All voted "Aye" and Ordinance O-05-24 passed.

#### Ordinance O-06-24

County Administrator, Matt Elberfeld read the title summary for the second reading of Ordinance O-06-24, "An Ordinance of the Campbell County Fiscal Court relating to the annual budget and appropriations of Campbell County, Kentucky for the Fiscal Year 2024 – 2025 (FY25)."

Motion was made to adopt Ordinance O-06-24 by Commissioner Tom Lampe, seconded by Judge/Executive, Steve Pendery.

The Judge/Executive and Commissioners thanked Finance Director/Treasurer, Laura Lewis for the previous Budget Report on May 15, 2024.

All voted "Aye" and Ordinance O-06-24 passed.

# **New Business**

County Administrator, Matt Elberfeld presented new business.

#### R-43-24 Resolution

County Administrator, Matt Elberfeld read the title summary for Resolution R-43-24, "A Resolution of the Campbell County Fiscal Court relating to the adoption of the revised Campbell County Emergency Operations Plan, prescribing the regulations governing disaster and emergency mitigation, preparedness, response and recovery services in and for Campbell County, Kentucky."

Motion was made to adopt Resolution R-43-24 by Commissioner Brian Painter, seconded by Commissioner Tom Lampe. All voted "Aye" and Resolution R-43-24 passed.

# R-44-24 Resolution

County Administrator, Matt Elberfeld read the title summary for Resolution R-44-24, "A Resolution Accepting HB1 Appropriation authorizing resolution to accept and transfer administration." Mr. Elberfeld explained these funds are from the Kentucky Department for Local Government for General James Taylor Park and transferring the funds and project administration to the City of Newport."

Motion was made to adopt Resolution R-44-24 by Commissioner Tom Lampe, seconded by Commissioner Geoff Besecker. All voted "Aye" and Resolution R-44-24 passed.

# R-45-24 Resolution

County Administrator, Matt Elberfeld read the title summary for Resolution R-45-24, "A Resolution of the Campbell County Fiscal Court adopting the Northern Kentucky Area Development District's Title VI Program Plan."

Motion was made to adopt Resolution R-45-24 by Commissioner Geoff Besecker, seconded by Judge/Executive, Steve Pendery. All voted "Aye" and Resolution R-45-24 passed.

County Administrator, Matt Elberfeld read the title summary for Resolution R-46-24, "A Resolution of the Campbell County Fiscal Court amending the Administrative Code and acknowledging the annual review of the Campbell County Administrative Code per Kentucky Revised Statues 68.005."

Finance Director/Treasurer, Laura Lewis requested a motion to authorize staff to purchase a 2024 Chevy Equinox from the state master agreement 758 2300000802 from Bachman Auto Group for the Housing Deputy Director. Ms. Lewis said the vehicle is to be used for transportation for inspections, conferences, and training, and the estimated cost from the state master agreement is \$28,675 which is included in the FY24 budget.

Ms. Lewis said the vehicle is to be used for transportation for staff attending training and routine jail transportation needs, and the estimated cost from the state master agreement is \$62,405 which is included in the FY24 budget.
