The Campbell County Fiscal Court held a regular meeting on Wednesday, July 17, 2024 at 5:30 PM, at the Campbell County Administration Building, 1098 Monmouth Street, Newport, Kentucky. Campbell Media recorded the regular meeting and broadcasted it on the Campbell Media website.

Recognition of Citizens/Public Officials

County Attorney, Steve Franzen explained why it is difficult to enforce this law. He said a possible solution is for neighbors to come together to discuss an informal agreement or solution.

Police Chief, Craig Sorrell also explained why it is difficult to enforce this law, especially during the time surrounding the July 4th Holiday. Chief Sorrell told Mr. Geigor to contact the Campbell County Police Department directly to discuss his concerns and to request more police patrol through Darlington Creek.

County Administrator, Matt Elberfeld presented new business.

County Administrator, Matt Elberfeld read the title summary of Resolution R-57-24, "A Resolution of the Campbell County Fiscal Court approving the Campbell County Health Department tax rate for fiscal year 2025 for the Campbell County Public Health Taxing District."

Motion was made to adopt Resolution R-57-24 by Commissioner Brian Painter, seconded by Judge/Executive, Steve Pendery. All voted "Aye" and Resolution R-57-24 passed.

County Administrator, Matt Elberfeld read the title summary of Resolution R-58-24, "A Resolution of the Campbell County Fiscal Court authorizing the Judge/Executive to extend the contracts with Rumpke of Kentucky INC. to provide recyclables collection services at designated sites and trash disposal services for county cleanups."

Commissioner Geoff Besecker mentioned that the slight increase may not be noticeable because the amount dropped off at the collection events may be reduced due to the new great voucher program.

He said the 2024 request is for \$1,075 which is to offset Campbell County Animal Services spay and neuter costs.

CCDC has been awarded a 50/50 match grant of \$50,000, the match for which is included in the FY25 Commissary budget.
