CAMPBELL COUNTY, KENTUCKY FISCAL COURT MINUTES

April 16, 2025

The Campbell County Fiscal Court held a regular meeting on Wednesday, April 16, 2025, at 5:30 PM, at the Campbell County Administration Building, 1098 Monmouth Street, Newport, Kentucky. Campbell Media recorded the meeting and broadcast it on the Campbell Media website.

Regular Meeting

Judge/Executive, Steve Pendery called the meeting to order at 5:30 PM.

Roll Call

Following the roll call, a quorum was declared present.

Minutes

Judge/Executive, Steve Pendery requested a motion to approve the minutes from the Regular Fiscal Court Meeting on April 2, 2025.

Motion was made to approve the minutes from the Regular Fiscal Court Meeting on April 2, 2025 by Commissioner Brian Painter, seconded by Commissioner Geoff Besecker. All voted "Aye" and the motion passed.

New Business

County Administrator, Matt Elberfeld presented new business.

R-17-25 Resolution

County Administrator, Matt Elberfeld read the title summary for Resolution R-17-25, "A Resolution allocating Senior Citizens Payroll Tax Fund for Fiscal Year 2026." The Senior Citizens payroll tax funds allocated will total \$757,070. Campbell County Senior Citizens incoming payroll tax funds will be allocated to the agencies serving older adults in the amount of \$316,070 in addition to \$406,000 for the Campbell County Senior Center and \$35,000 for the Senior Picnic.

Motion was made to adopt Resolution R-17-25 by Commissioner Geoff Besecker seconded by Commissioner Tom Lampe. All voted "Aye" and Resolution R-17-25 passed.

R-18-25 Resolution

County Administrator, Matt Elberfeld read the title summary for Resolution R-18-25, "A Resolution allocating Mental Health/Intellectual Disabilities Payroll Tax Funds for Fiscal Year 2026." The Mental Health/Intellectual Disabilities (MH/ID) payroll tax funds allocated will total \$1,512,365. Campbell County MH/ID incoming payroll tax funds will be allocated to the agencies serving the MH/ID population in the amount of \$1,102,365 in addition to \$410,000 as follows:

- Court Ordered Indigent Guardianship Evaluations: \$5,000
- Youth Services Officer: \$130,000
- NKY Office of Drug Control Policy/Helpline: \$200,000
- Human Services Administration: \$75,000

Motion was made to adopt Resolution R-18-25 by Commissioner Geoff Besecker seconded by Commissioner Tom Lampe. All voted "Aye" and Resolution R-18-25 passed.

Judge/Executive, Steve Pendery asked Human Services Manager, Allyn Reinecke to give a brief explanation of what she does and how Campbell County partners with Boone and Kenton Counties to ensure better coverage for all the agencies under consideration.

Human Services Manager, Allyn Reinecke said that all three counties work together each year to put out a joint request for proposals. They get together and analyze the RFPs and go back to the agencies for feedback. They do site visits together every two years to audit client files and meet with their staff. It cuts down on the administrative burden for non-profits. Funds are given on a reimbursement basis, and agencies submit monthly reports to each of the three counties separately.

Motion

County Administrator, Matt Elberfeld read a motion to enter into contract addendum #3 with the Emergency Shelter of NKY (ESNKY) to update the per night reimbursement rate for winter overflow sheltering in Campbell County from \$1,428.57 per night to \$1,580.46 per night to reflect actual costs incurred due to a location change during the winter.

Motion was made by Commissioner Geoff Besecker, seconded by Commissioner Tom Lampe.

Commissioner Tom Lampe commented that it was a much-needed service and it was wonderful that Campbell County was able to help, and that the Emergency Shelter of Northern Kentucky CEO, Kim Webb did a wonderful job.

All voted "Aye" and the motion passed.

County Administrator's Report

County Administrator, Matt Elberfeld presented a report.

R-19-25 Resolution

County Administrator, Matt Elberfeld read the title summary for Resolution R-19-25, "A Resolution of the Campbell County Fiscal Court establishing school zone origins and termini for Reiley Elementary School.

Motion was made to adopt Resolution R-19-25 by Commissioner Tom Lampe seconded by Commissioner Brian Painter. All voted "Aye" and Resolution R-19-25 passed.

R-20-25 Resolution

County Administrator, Matt Elberfeld read the title summary for Resolution R-20-25, "A Resolution of the Campbell County Fiscal Court establishing school zone origins and termini for Campbell County High School".

Motion was made to adopt Resolution R-20-25 by Commissioner Geoff Besecker seconded by Commissioner Brian Painter. All voted "Aye" and Resolution R-20-25 passed.

County Commissioners' Report

Commissioner Geoff Besecker wished everyone a Happy Easter and said that he hoped it would be a wonderful season for families.

Finance Director/Treasurer, Laura Lewis requested a motion to authorize the Judge/Executive to execute a service agreement with Toshiba for copiers in the Human Resources and Planning & Zoning Departments. Ms. Lewis explained both of the current copiers in these departments are more than 5 years old and have reached the end of useful life. The current Human Resources copier has been retired by the vendor with no repair and maintenance parts available. The Planning & Zoning copier's lease has ended, and the county will receive a refund of \$156 when the current agreement terminates upon receipt of the machine.

Motion was made by Commissioner Geoff Besecker, seconded by Judge/Executive, Steve Pendery. All voted "Aye" and the motion passed.

Finance Director/Treasurer, Laura Lewis requested a motion that Campbell County Fiscal Court utilize FY 2026 Kentucky Transportation Cabinet, Rural Secondary Flex Funds in the amount of \$181,600.00.

Motion was made by Commissioner Geoff Besecker, seconded by Judge/Executive, Steve Pendery. All voted "Aye" and the motion passed.
