A RESOLUTION RELATING TO THE NORTHERN KENTUCKY SOLID WASTE MANAGEMENT AREA APPOINTING THE BOONE COUNTY ATTORNEY'S OFFICE TO ADVISE THE NORTHERN KENTUCKY SOLID WASTE MANAGEMENT AREA ON ALL MATTERS PERTAINING TO ITS DUTIES.

NOW, THEREFORE, BE IT RESOLVED BY THE NORTHERN KENTUCKY SOLID WASTE MANAGEMENT AREA, COMMONWEALTH OF KENTUCKY:

SECTION I

That the Northern Kentucky Solid Waste Management Area (NKSWMA) Governing Body appoints the Boone County Attorney's Office to advise the partners on all matters pertaining to their duties. The partners shall have the discretion to delegate authority to the Boone County Attorney's office, not otherwise forbidden by law. The Boone County Attorney's office shall attend all meetings of the board whenever the partners request them to attend, except executive sessions when the partners do not desire their presence. The Boone County Attorney's office shall advise the partners on all legal matters on which it is requested to give advice.

SECTION II

That this Resolution is hereby approved and adopted in Open Session of the Northern Kentucky Solid Waste Management Area this 10th day of April, 2025.
