County Commissioners' Report

Commissioner Geoff Besecker gave a report on a tour that he, Judge/Executive Steve Pendery, and Solid Waste Coordinator, Megan Clere-Abrams attended at the Rumpke Recycling Center in Cincinnati, Ohio. He also explained curbside recycling opportunities, including the Hefty Renew Program that are available

to all Campbell County residents including in unincorporated areas. He encouraged residents that if they have any questions or want to learn more, to contact Solid Waste Coordinator, Megan Clere-Abrams and she can explain how to get started. He said there are 400 similar recycling centers nationwide but that the Rumpke site they toured is the 4th largest in the country. Commissioner Besecker said the site processes 55 tons of recycled material every hour. Lithium-ion batteries are one of the things that should not be put in recycle bins because it disrupts operations and poses frequent fire hazards. He said the technology incorporated into waste is incredible. Commissioner Besecker thanked Ms. Clere-Abrams for organizing the tour.

Judge/Executive, Steve Pendery said he was astonished by the technology.

Commissioner Brian Painter encouraged people to attend Campbell County Extension Agriculture Center Grand Opening and Ribbon Cutting on Friday, July 18th and the Campbell County Farm Tour on Saturday, July 19th.

Finance Director/Treasurer's Report

Finance Director/Treasurer, Laura Lewis, presented the Finance Director/Treasurer's Report.

R-49-25 Resolution

Finance Director/Treasurer, Laura Lewis read the title summary for Resolution R-49-25, "A Resolution of the Campbell County Fiscal Court authorizing the Judge/Executive to execute any grant contract documents related to a Rescue Aid Program Grant with the Kentucky Division of Emergency Management for the Campbell County LandSAR Team." Ms. Lewis stated the estimated cost of the Polaris ATV is \$27,000 and the local match estimate is \$5,400 with an expected 80/20 split. The local match was included in the Fiscal Year 2026 budget.

Motion was made to adopt Resolution R-49-25 by Commissioner Brian Painter, seconded by Commissioner Geoff Besecker. All voted "Aye" and Resolution R-49-25 passed.

Finance Director/Treasurer, Laura Lewis read the title summary for Resolution R-50-25, "A Resolution of the Campbell County Fiscal Court authorizing the County Judge/Executive to execute a contract with the Ohio-Kentucky-Indiana (OKI) Regional Council of Governments to provide Regional Planning services for Fiscal Year 2026."

Motion was made to adopt Resolution R-50-25 by Commissioner Geoff Besecker, seconded by Judge/Executive, Steve Pendery. All voted "Aye" and Resolution R-50-25 passed.

Finance Director/Treasurer, Laura Lewis requested a motion to renew the service agreement with the communications firm Cerkl for a period of two years, effective July 1, 2025 at an annual cost of \$10,510. Ms. Lewis stated the Cerkl communications platform has been used by staff since 2019 for both internal staff communications and external resident/business owner communications.

Finance Director/Treasurer, Laura Lewis requested a motion to approve a change order of \$13,182.50 for the Plum Creek Bridge Replacement Project. Ms. Lewis stated the original bid from Todd Johnson Contracting was \$314,398.79 and the change order brings the total project cost to \$327,581.29. The change order was included in the Fiscal Year 2026 budget.

Motion was made by Commissioner Geoff Besecker, seconded by Judge/Executive, Steve Pendery. All voted "Aye" and the motion passed.

Finance Director/Treasurer, Laura Lewis requested a motion for permission to authorize staff to issue an invitation to bid the resurfacing and crack sealing of the existing tennis courts at AJ Jolly Park. Ms. Lewis stated the surface will be re-striped for two tennis courts and two pickleball courts with new nets. The cost of the project is estimated at \$75,000 and is included in the Fiscal Year 2026 budget.

Motion was made by Judge/Executive Steve Pendery, seconded by Commissioner Geoff Besecker. All voted "Aye" and the motion passed.

Finance Director/Treasurer, Laura Lewis requested a motion for permission to authorize staff to issue an invitation to bid the replacement of the entire bridge structure, KYTC 019C00006N, on Lower Tug Fork at KY 547, and Four-Mile Road.

Motion was made by Commissioner Geoff Besecker, seconded by Judge/Executive, Steve Pendery. All voted "Aye" and the motion passed.
