**II. Instructions to Bidders – Terms and Conditions**

The Campbell County Fiscal Court will accept bids for an Amphibious Excavator until Thursday, February 5, 2026 at 10:00 AM. The County is interested in purchasing only one excavator.

**A. Authority**

1. This Invitation for Bids is issued in accordance with applicable provisions of the Campbell County Administrative Code Chapter 4 Purchasing and Contracts.
2. This is not an order. Please read all instructions, terms, and conditions carefully.

**B. Transmission**

1. Bids should be submitted in a sealed envelope addressed to Campbell County Finance, 1098 Monmouth Street, Suite 322, Newport, KY 41071 or to the front reception desk.
2. The envelope must be clearly marked with the bid title. **“SEALED BID – AMPHIBIOUS EXCAVATOR”**

3. Bids will be received at the CCFC Finance department until the date specified. Please contact us at 859-547-1827 with any questions.
4. Late bids, those not clearly marked, or those that do not follow the instructions will not be accepted.
5. Campbell County Fiscal Court will not be held responsible for any premature opening or failure to open any bid not properly addressed and identified as stated above.

**C. Instructions - Please Read Carefully**

1. Bid form must be signed in blue ink.
2. One original and one copy of the bid must be submitted. Keep a copy of the bid for your records.
3. A list of qualifications and a minimum of three references are required. Please refer to Section XIV.
4. Bidders should verify their bids before submission. Errors in preparing the submission confers no right of withdrawal or modification after open.
5. Bidders are responsible for all costs associated with the preparation of response to the invitation for bids. Campbell County is not liable for any costs incurred by bidders in their response to this request.
6. A pre-bid or pre-award visit to bidder may be required at the discretion of the Owner.
7. Whenever a specific "Brand Name" is used in these specifications, it is used for descriptive purposes only. Whenever or wherever the Bidder takes exceptions to the Specifications, such exceptions shall be listed on the "Exception Sheet" of these specifications, and signed by the Bidder. The Bidder must use the attached "Bid Form" as NO OTHER SHEET/FORM will be accepted. The Bidder shall also attach to the "Bid Form", any descriptive information and literature showing the items on which the bid was based. Campbell County Fiscal Court shall be the sole judge of whether a bid meets the intent of these specifications.

9. Delivery Rejection - Equipment must meet specifications as set forth in the specifications section, otherwise delivery will be rejected. Corrections to equipment cannot be carried out on CCFC property.
10. It will be the responsibility of the awarded vendor/manufacture to provide a list of dealers in the Commonwealth of Kentucky and the State of Ohio who are authorized to provide warranty and service repair. This list shall be submitted with the bid.
11. Product Specifications - All parts not specifically mentioned, which are necessary to provide a complete unit, or normally furnished as standard equipment shall be furnished. The parts shall conform in strength, quality of material and workmanship to what is normally provided in the industry.
12. This equipment must meet all Federal and State regulations.
13. Bidders are required to submit with their bids, the latest literature that fully describes the units being bid.
14. The signing of this bid shall be considered a certification that the model as bid herein is the latest current, model and will include the manufacturer's latest engineering changes. All engine and exhaust combinations will have at least one-year proven compatibility and be in

good working order. Production history of engine and exhaust combination must be submitted with bid.

15. CCFC will consider performance history of similar equipment, vendor's service and vendor's overall responsiveness to CCFC and other entities utility of the products.
16. National Bid(s) – Access to national bids can be used to obtain best pricing. Sourcewell – Campbell County #144344
17. CCFC will accept delivery from dealer stock provided that the vehicle bid meets specifications.
18. Diesel fuel and Diesel Exhaust Fluid (DEF) tanks shall be full at time of delivery.

**D. Pricing**

1. Firm prices are required.
2. All prices quoted must be F.O.B. destination shown in shipping instructions on specification.
3. Insert time discounts, if any. Time discounts will not be a factor in award determination.
4. Quotations must be submitted on the bid price sheet indicating unit price, total extension of each item, and grand total of bid.
5. Unit prices should be based on the bid specification instructions. Please direct questions to the County at 859-547-1827 prior to submitting a bid.
6. Trade discounts must be deducted by the vendor in calculating the unit price. The unit price must be net.

**E. Warranty**

The selected Bidder shall provide warranty on any services and materials found to be defective or faulty due to imperfect or bad workmanship/materials based on the warranty required in the bid specifications at no additional cost to the County. This warranty does not change or void any warranties expressed or implied to which the purchase is subject.

**F. Regulatory Compliance**

1. Pursuant to the provisions of KRS 45A.343, the contractor or vendor is required to reveal to Campbell County Fiscal Court any final determination of a violation of KRS Chapters 136, 139, 141, 337, 338 and 342 by the contractor or vendor within the previous five (5) years; and further that said contractor or vendor has been and is in continuous compliance with the provisions of KRS Chapters 136, 139, 141, 337, 341, and 342 for the duration of the contract. The failure of a contractor or vendor to reveal a final determination of a violation to a local government, or to comply with the statutory requirements, is considered grounds for cancellation of a contract and disqualification of the contractor or vendor from eligibility for any Campbell County Fiscal Court contracts for a period of two (2) years.
2. All bidders must possess all federal, state, and local qualifications licenses to provide products or services in Campbell County, the Commonwealth of Kentucky, and the United States.
  - a. Including, but not limited to
    - i. Business license issued by the Occupational License Department of Campbell County (see County website for application)

- ii. Hazardous Communication Program (OSHA)
  - iii. Workers' Compensation Certificate
  - iv. Liability Insurance
- 3. Successful bidder shall comply with the Kentucky Human Rights Act, HRA 344.150-344.270 as amended and any rules and regulations promulgated therewith, including, but not limited to the Equal Employment Opportunity EEO 45.550 – 45.640 which is incorporated herein by reference. Furthermore, the successful bidder shall comply with the Employment Discrimination Act, EDA 344.040, 344.050 as amended. Per Title VI of the Civil Rights Act of 1964, no person in the United States shall, on the grounds of race, color, or national origin, be excluded from participation in, be denied the benefits of, or be otherwise be subjected to discrimination under any program or activity for which a project, contractor/vendor or the county may receive federal financial assistance.
- 4. The scoring of this bid is subject to reciprocal preference for Kentucky resident bidders. Bidders not claiming resident bidder status need not submit the corresponding affidavit.

#### **G. Bonds**

- 1. Bid bonds, performance bonds, and payment bonds as prescribed by KRS 45A.430, 435, 440 are required for any bids/proposals that exceed \$99,999. Each bid, or the combination of submitted bids, over \$99,999 must be accompanied by a 5% bid bond of the grand total of the bid. The bid bond of the successful bidder will be retained until a performance bond has been executed and approved, after which the bid bond will be returned. The successful bidder will be required to post a performance bond in the amount of 100% of the bid if awarded a contract over \$99,999. Bonding and surety requirements may vary by project/commodity. Please contact Owner for more information.

#### **H. Reserved Rights**

- 1. Campbell County Fiscal Court reserves the right to reject any or all bids, including without limitations the right to reject any or all nonconforming, non-responsive, incomplete, unbalanced, or conditional bids, to waive formalities, and to reject the bid of any Bidder if CCFC believes that it would not be in the best interest of Campbell County Fiscal Court to make an award to that Bidder. CCFC also reserves the right to negotiate with the apparent qualified Bidder to such an extent as may be determined by Campbell County Fiscal Court.
- 2. CCFC reserves the right of renewal for any service and maintenance contracts that may be needed for a minimum of two (2) one (1) year periods.
- 3. In the event the successful bidder fails to commence substantial work on the project within thirty (30) days and the County does not waive this requirement, the County shall have the option to reject the bid and to void the contract, and in such event to either accept the next lowest and best bidder or to negotiate with the best qualified bidder
- 4. In the event the successful bidder fails to complete the project by the completion date entered on the bid form and the County has not waived this requirement in writing, the County shall receive from the bidder (or withhold from the bidder, at its option) liquidated damages of 1% per project per calendar day.
- 5. All the terms and conditions of these instructions to bidders and the specifications for this project shall constitute, the part of, and incorporate into, the contract between the County and the successful bidder.

#### **I. Award**

It is the intent of Campbell County Fiscal Court to award a contract to the lowest responsible bidder meeting specifications. CCFC reserves the right to determine the lowest responsible bid/offer in any way determined to be in the best interests of Campbell County. Award will be

based on the following factors (where applicable): (a) adherence to all conditions and requirements of the bid/proposal specifications; (b) price; (c) qualifications of the bidder, including past performance, financial responsibility, general reputation, experience, service capabilities, and facilities; (d) delivery or completion date; (e) product appearance, workmanship, finish, taste, feel, overall quality, and results of product testing; (f) maintenance costs and warranty provisions; and (g) repurchase or residual value.

**BID ITEM 1**

**AMPPHIBIOUS EXCAVATOR - OPERATING WEIGHT – 13,000 LBS.**

- A. OPERATING WEIGHT:** EXCAVATOR OPERATING WEIGHT 13,000 LBS. **THIS WEIGHT DOES NOT INCLUDE PONTOONS**
- B. ENGINE:** LIQUID-COOLED DIESEL WITH BLOCK HEATER AND A MINIMUM OF 49 HP. ENGINE SHALL INCLUDE THREE SELECTABLE POWER MODES: POWER MODE, SMART MODE OR ECONOMY MODE. MACHINE SHALL BE EQUIPPED WITH ON-DEMAND ELECTONICALLY-DRIVEN FANS, WITH REVERSING CAPABILITY STANDARD. MACHINE SHALL BE EQUIPPED WITH AN AIR PRECLEANER SYSTEM INTEGRATED INTO AIR FILTER HOUSING COVER.
- C. POWERTRAIN/TRANSMISSION:** TRAVEL SPEED SHALL BE AT LEAST 1.2 MPH.
- D. HYDRAULIC SYSTEM:** MACHINE SHALL HAVE ELECTRO-HYDRAULICALLY CONTROLLED MAIN VALVE FOR ALL IMPLEMENT FUNCTIONS.
- E. OPERATOR CAB:** CLOSED CAB WITH AN ADJUSTABLE SUSPENSION-TYPE SEAT. CAB SHALL HAVE ADJUSTABLE FRONT WINDSHIELD. CAB SHOULD INCLUDE: HORN, WIND- SHIELD WIPERS, HEAT, AIR CONDITIONING, DEFROSTER, RADIO, INSTRUMENT PANEL WITH GAUGES, WARNING LAMPS, AND HOUR METER. CAB MUST ALSO HAVE PILOT-OPERATED JOY STICKS AND CONTROL PATTERN CHANGER. MACHINE SHALL HAVE TWO POSITION TILTABLE LEFT-HAND JOYSTICK CONSOLE TO AID INGRESS/EGRESS. MACHINE SHALL BE EQUIPPED WITH PUSH-BUTTON START IGNITION. MACHINE SHALL BE EQUIPPED WITH A JOB DIAL LOCATED ON RIGHT-HAND CONSOLE TO ALLOW OPERATOR TO SCROLL THROUGH MONITOR MENU FUNCTIONS. MACHINE SHALL UTILIZE ELECTRO-HYDRUALIC OPERATED CONTROL LEVERS POSITIONED SO THE OPERATOR CAN OPERATE WITH ARMS ON THE ARMRESTS. CAB TO BE PRE-WIRED, POWER AND ANTENNA, FOR TWO-WAY RADIO INSTALLTION BY OWNER, LOCATION TO BE DETERMINED.
- F. ELECTRICAL:** EXCAVATOR SHALL HAVE A 12 VOLT ELECTRICAL SYSTEM WITH A MINIMUM 35 AMP ALTERNATOR, CAB MOUNTED LED WORK LIGHTS IN FRONT, BACK, AND ON RIGHT SIDE OF BOOM. TRAVEL ALARM, BACK AND SIDE-MIRROR CAMERAS.
- G. WORKING RANGE:** MACHINE SHALL HAVE A MINIMUM 23' GROUND REACH. BOOM AND STICK WILL BE PLUMBED FOR AUXILLARY HYDRAULICS.
- H. HYDRAULIC THUMB:** OPTION - SEE BID SHEET.
- I. BUCKET:** INCLUDED WITH MACHINE. HEAVY DUTY DITCHING/GRADING BUCKET TO BE USED FOR DREDGING. BUCKET WILL BE SELF DRAINING AND AS LARGE AS THE MACHINE CAN SAFELY ACCOMMODATE.
- J. TRAVEL AND BRAKES:** TRAVEL SHALL BE FULLY HYDROSTATIC. A SEPARATE MOTOR SHALL DRIVE EACH TRACK/PONTOON FOR INDEPENDENT MOVEMENT. SERVICE BREAKING SHALL BE AUTOMATIC AND HYDRAULIC THROUGH THE DRIVE MOTORS. FINAL DRIVE CAN BE PROVIDED BY CHAIN AND SPROCKET BUT MUST BE PROTECTED. CHAIN MUST BE ADJUSTABLE.

- K. ADDITIONAL FEATURES:** GRADE SENSORS AND ALL HARDWARE/SOFTWARE NEEDED FOR DATA LOGGING OF ALL DIGGING MOVES ALONG WITH IN CAB VISUAL DISPLAY TO BE INCLUDED. SYSTEM WILL WORK EVEN WITH BUCKET UNDERWATER TO A MINIMUM DEPTH OF 8'. A 360-DEGREE CAMERA SYSTEM VISIBLE ON PRIMARY MACHINE DISPLAY SHALL BE AVAILABLE AS AN OPTION. MACHINE SHALL HAVE STANDARD REARVIEW AND RIGHT- HAND CAMERA WITH THREE MIRRORS AND ONE ADDITIONAL CAB MIRROR. MACHINE SHALL BE EQUIPPED WITH CENTRALLY LOCATED STEPS PERPENDICULAR TO TRACKFRAME ALLOWING THREE POINTS OF CONTACT TO THE SERVICE PLATFORM. CATWALKS AND RAILINGS TO BE INCLUDED.
- L. UNDERCARRIAGE:** PONTOON 21' MINIMUM LENGTH, 9' MINIMUM WIDTH, STEEL TRACKS, TRACKS WILL HAVE A MINIMUM WIDTH OF 3'.
- M. PONTOONS:** EACH PONTOON WILL CONTAIN MINIMUM OF TWO BULKHEADS CREATING A MINIMUM OF THREE INDEPENDENT WATERTIGHT COMPARTMENTS. ALL DRIVE MECHANISMS FOR TRACKS WILL BE PROTECTED AND SHROUDED. TRACK SIDE MOVEMENT AND TRACK JUMPING WILL BE ENGINEERED AND BUILT TO NOT BE AN ISSUE. PONTOONS WILL BE BLASTED TO SP10 SPECIFICATIONS INSIDE AND OUT AND THEN COATED WITH RUST PROOF COATINGS AND PAINT INSIDE AND OUT.
- N. HYDRUALIC TRACK TENSIONING CYLINDER:** MUST BE PROTECTED FROM WATER AND DEBRIS.
- O. CLEATS:** WILL BE CONSTRUCTED OF MARINE GRADE COMPONENTS.

- A. OPERATING WEIGHT:** EXCAVATOR OPERATING WEIGHT 19,000 LBS. **THIS WEIGHT DOES NOT INCLUDE PONTOONS**
- B. ENGINE:** LIQUID-COOLED 4 CYLINDER DIESEL WITH BLOCK HEATER AND A MINIMUM OF 68 HP. ENGINE SHALL INCLUDE THREE SELECTABLE POWER MODES: POWER MODE, SMART MODE OR ECONOMY MODE. MACHINE SHALL BE EQUIPPED WITH ON-DEMAND ELECTONICALLY-DRIVEN FANS, WITH REVERSING CAPABILITY STANDARD. MACHINE SHALL BE EQUIPPED WITH AN AIR PRECLEANER SYSTEM INTEGRATED INTO AIR FILTER HOUSING COVER.
- C. POWERTRAIN/TRANSMISSION:** TRAVEL SPEED SHALL BE AT LEAST 1.2 MPH.
