CAMPBELL COUNTY FISCAL COURT MINUTES

JUNE 6, 2012

A regular meeting of the Campbell County Fiscal Court was held on Wednesday, June 6, 2012, 7:00 p.m. at the Campbell County Courthouse located at 8352 East Main Street, Alexandria, Kentucky.

The meeting was called to order at 7:00 p.m. by Judge Pendery. Cable Access was present to film the meeting.

Judge Pendery asked for a moment of silence followed by the Pledge of Allegiance. Following roll call, a quorum was declared present.

Minutes from the Fiscal Court regular meeting of May 16, 2012 were presented. Motion was made by Commissioner Garrett, seconded by Commissioner Painter to approve the minutes. All voted "AYE" and the motion passed.

Judge Pendery called on Andy DeMoss of Ray, Folley & Hensley, Auditors, to present his report on the audit of the County's 2011 financial statements. Mr. Demoss explained that the State Auditor conducts an audit on every county in Kentucky every year. They contract with independent auditors to perform many of these audits. The main objective of the audit is to make sure that the financial statements prepared by the County are prepared in accordance with generally accepted accounting principals and to insure compliance with the law. He explained each of the three reports that they prepared as a result of their audit and the budgetary comparison schedules. Mr. DeMoss stated that the Fiscal Court staff was very cooperative and they were finished with the audit in a month. He stated that Campbell County was the only audit

that they performed last year, but the year before they performed four audits. Mr. DeMoss then answered questions from the audience.

Judge Pendery invited comments from the public.

Charles Lonneman, Cleves and Lonneman Jewelers, 319 Fairfield Avenue, Bellevue, addressed the Fiscal Court about the proposed Used Property Business regulations. He stated that the proposed regulations are so invasive and time-consuming that it would be very hard to keep up with. Mr. Lonneman stated that for example, during a six day period in May he bought \$86,000 worth of items, about 3,500 separate items that he would have to photograph and log – it would be impossible for him to do this by 11:00 a.m. of the next day. He also stated that it would be invasive to take photographs and ask for personal information from his clients, especially elderly people. Mr. Lonneman stated that he has complied with Bellevue's ordinance. He stated that Campbell County's ordinance is anti-business.

Kevin Gordon, Wilder, suggested that while the County is working on its budget it may want to give strong consideration to replacing individuals by contracting the work to agencies that provide services such as IT and Human Resources. He further encouraged the Fiscal Court to, in lieu of a raise for employees, give a bonus instead which may cut the County's pension costs for employees.

Erik Hermes, Campbell County resident, property owner and business owner, asked if there were any increases in the 2013 budget even as little as one or two percent. He stated that the serious economic problems facing this country are caused by excessive governmental spending, governmental regulations and excessive taxation. He knows first-hand that Campbell County working families are suffering – they do not have the money to pay for basics and are then faced with increased utility rates and a variety of taxes. Mr. Hermes quoted several residents that he has talked to. He stated that property values are predicted to decrease and more families are losing their homes. He suggested that the Fiscal Court ask themselves whether they are part of the solution or part of the problem before passing any budget increases.

Jim Pfister, Campbell County resident, pointed out that there is a \$62,000 allocation to the fire department in the budget; why does the Fiscal Court tax residents to give money to another taxing district that has its own way of raising money. Judge Pendery stated that the organization receiving the \$62,000 does not have the capability of raising money – they have to get money from the districts, cities and county in order to operate their educational and fire training programs. If the Fiscal Court did not provide this funding, the cost would simply be shifted to another governmental agency.

Jack Decker, Claryville, asked why the Fiscal Court operates A J Jolly Golf Course at a loss, why is the Fiscal Court in competition with private enterprise, and why does the golf pro receive the benefits that he does. Judge Pendery explained that if they shut down the golf course the loss would be bigger because the income from the golf course pays for overhead that would continue if the course was closed i.e. repayment of money borrowed to improve the golf course. He further stated that the golf course, opened in 1962, did not always operate at a loss. Lloyd Rogers suggested that the Fiscal Court lease the golf course to a private operator. Judge Pendery

stated that private golf courses all over the country are having financial problems and closing. He stated that all three northern Kentucky counties have explored alternatives to operating their own courses. He then explained why the golf pro gets the benefits that he does and about maintenance employees for the course. Mr. Decker then asked what the "voucher program" is in the budget. He was told that this is a housing voucher program for senior citizens.

Lloyd Rogers, Alexandria, asked how much is in the budget for OKI; he did not make payments to OKI when he was county judge, and wonders why the Fiscal Court is paying for a council that is across state lines which is prohibited by the Constitution. Judge Pendery stated that the type of arrangement that the Fiscal Court has with OKI has been upheld by courts across the country. Without OKI, the region would not get federal money for transportation projects. He described the work that OKI does and that they provide reports and plans to the State.

Helen Labiski, Ft. Thomas, suggested that the Fiscal Court take a hard look at the proposed budget. She volunteers at a local pantry and at St. Vincent DePaul and has seen many downtrodden and starving people in Ft. Thomas and other communities. She had been told that the Fiscal Court provides assistance to people for payment of utilities. However everybody that applies has been turned down. She suggested that there are probably ways that the budget could be cut.

Ken Moellman, Campbell County resident, asked how much the Fiscal Court contributes to North Key and do they plan to discontinue funding like Kenton and Boone Counties have. Judge Pendery replied that they will not discontinue the contribution, but it is less than in the past.

Ken Moellman stated that he had occasion on the last two days to drive by New Perceptions in Kenton County, and saw the TANK mini buses lined up at the facility many with only one passenger aboard. He suggested that they could coordinate trips better to save fuel and manpower. He stated that the County gives a lot of money to TANK, but he sees a lot of empty buses on the road.

Linda Pfister, Campbell County resident, stated that she has watched her taxes increase every year since living here. She voted for some of the Fiscal Court members who promised to be responsible to the taxpayers. She seems to hear about a lot of new spending when attending the meetings. She listed numerous taxes that are increasing in addition to the County's taxes. Ms. Pfister requested that the Fiscal Court members watch out for the residents. Judge Pendery explained why the Fiscal Court does not use the State form for its budget. When they set the budget, they try to do it in such a way that it does not have to be amended. They hope not to spend as much money that is allocated in the budget, and rarely do. Judge Pendery offered to meet with people to answer questions about the budget.

Robert Horine advised that the amount allocated from Mental Health/Intellectual Disability taxes to North Key is \$160,000 for this year. Each year agencies must submit proposals to the Fiscal Court for funding. The proposals are evaluated and chosen based on those that will deliver the greatest value for the money being spent on mental health services. He stated that the numbers and agencies change from year to year; if an agency is underperforming they will get dropped from the program. He explained why North Key's funding was decreased this year.

Wayne Turner, Chief of Police, Bellevue, Kentucky, stated that Newport and Bellevue have precious metals ordinances and Campbell County needs one as well. He stated that there is an increase in burglaries and this ordinance will give the police a much-needed tool to help solve these types of crimes. He encouraged the Fiscal Court to pass this ordinance and tweak it as needed. Chief Turner acknowledged that some of the requirements are time-consuming and burdensome for business owners. He explained how "Leads on Line" works and how it helps the police. Marshall Granger, jeweler, stated that this ordinance is not fair to independent jewelers. He has always taken information from clients when buying items from them, but does not want to release personal information about his clients for confidentiality reasons. Chief Turner urged the Fiscal Court to adopt the ordinance.

Brian Loos, Cynthiana, asked what the Fiscal Court estimates the compensating rate to be, and when they will vote on the property tax rate. Robert Horine explained that they will not get the compensating rate from the State until the end of July and then the Fiscal Court has 45 days to take action on it. Judge Pendery stated that they are assuming a 4% increase in revenue.

Sharon Neal, Bellevue, stated that she knows how it is to live in the upper 10% of incomes and now how it is to live in the lower 10% of incomes. She struggles and has had to make cuts herself. She requested that the Fiscal Court make cuts to its budget as well.

Larry Robinson, Campbell County Tea Party, stated that Boone and Kenton Counties have announced that they are not increasing taxes for 2013, and the Tea Party expects the same thing in Campbell County. They are willing to work with the Fiscal Court on its budget to help keep the costs down. Mr. Robinson stated that if the used property ordinance is not ready they shouldn't pass it. He advised that they will continue to fight the tax increase proposed by the library board. He requested that the Fiscal Court tell the library to stop incurring costs until they know the final results of the lawsuit and that they should perform a study to determine the necessity of a new library. Mr. Robinson stated that the Tea Party works hard to help the Fiscal Court be conservative; there is so much stuff in the budget that could be cut. Judge Pendery stated that there is not a lot that can be cut in the budget, and that the Fiscal Court is stingy compared to the state and federal governments. Commissioners Garrett and Painter discussed the Fiscal Court's ability to pay bonuses to its employees and the associated pension costs.

Michelle Snodgrass, Campbell County Commonwealth Attorney, thanked the Fiscal Court for past funding to operate the Felony Accelerated Sentencing Track (FAST) docket. She advised that as of November 2012, her office will self-fund this program. Hundreds of thousands of dollars in incarceration costs have been saved by utilizing this program. Ms. Snodgrass stated that they will continue this program, but will only need about one-third of the funds from the Fiscal Court to sustain them through October. She thanked the Fiscal Court for their assistance. Judge Pendery complimented Ms. Snodgrass on her efforts to save money and on investing her office's money to continue this program.

Melissa Williams presented old business with a second reading of Ordinance O-01-12 by title and summary. O-01-12 establishes regulations for the operation of used property businesses in Campbell County, Kentucky. Steve Franzen explained that he was requested by various

Campbell County Police Departments to draft regulations for used property businesses. Police agencies were frustrated with not being able to solve the increasing number of thefts, especially of precious metals which are quickly sold. After a number of meetings with police and local businesses, the current ordinance was presented to the Fiscal Court. With the adoption of regulations in surrounding communities, Campbell County has become the place to go to cash in stolen property. Mr. Franzen stated that ideally he'd like to have regulations that apply to the entire metropolitan area, but this ordinance provides a good tool for police in Campbell County. The police are a valuable public asset and need to be used efficiently. Commissioner Garrett made a motion to adopt O-01-12, seconded by Judge Pendery. Commissioner Garrett stated that they've been working on this ordinance for a long time; it needs to be adopted and then could be amended if needed. Commissioner Rechtin stated that he'd like to see a common ordinance applicable to all cities and counties. He was unaware that Bellevue's Mayor had not seen the ordinance. He stated that Leads on Line is a good tool and that he would commit to the Fiscal Court paying so that all police departments in the county could have access to it. The ordinance should be done right before it is passed. For these reasons, he will vote no. Commissioner Painter stated that as a small business owner he has had to make changes to his business in keeping with the times and the economy. He listed many of the taxes that people are subject to and stated that it is almost impossible for a private business to survive. He stated that they don't need more government intrusion in private business. Commissioner Painter agreed that the police are an expensive public asset, however small business owners don't have the same types of benefits that police do. They need to give small businesses a break. Commissioner Garrett and Judge Pendery voted "AYE", Commissioners Rechtin and Painter voted "NAY" and the motion failed to pass. Commissioner Rechtin recommended that the ordinance be reviewed again in light of suggestions regarding the three-day waiting period, Leads on Line, county-wide applicability, and making Mayor Riehl aware of the ordinance. Mr. Franzen agreed with Commissioner Rechtin and urged him or Commissioner Painter to draft an ordinance that they think would assist the police.

Ms. Williams presented new business beginning with Resolution R-61-12 by title and summary. R-61-12 regards the annual review of the Campbell County Administrative Code. The Fiscal Court is statutorily required to review its Administrative Code in June of every year. Staff has reviewed the Code and recommends no changes at this time. Commissioner Rechtin made motion to adopt R-61-12, seconded by Commissioner Garrett. All voted "AYE" and the motion passed.

Resolution R-58-12 was read by title and summary given. R-58-12 authorizes the Judge/Executive to execute a Memorandum of Agreement with the Kentucky Department for Local Government office of Federal Grants for the creation of a multi-purpose pathway at A J Jolly Park. The Fiscal Court applied for and received a \$32,000 grant for the multi-purpose pathway at A J Jolly Park. Commissioner Garrett made a motion to adopt R-58-12, seconded by Judge Pendery. All voted "AYE" and the motion passed.

Resolution R-62-12 was read by title and summary given. R-62-12 approves submission for Flex Funds to the Kentucky Transportation Cabinet, Rural Secondary Road Program. These funds will be used to resurface CR 1115-Shaw Goetz Road and CR-1119 Yelton Road.

Commissioner Garrett made a motion to adopt R-62-12, seconded by Commissioner Painter. All voted "AYE" and the motion passed.

Resolution R-60-12 was read by title and summary given. R-60-12 adopts new policies and procedures for local agencies receiving allocations from Mental Health/Intellectual Disability and Senior Citizen Taxes. Commissioner Painter made a motion to adopt R-60-12, seconded by Commissioner Garrett. All voted "AYE" and the motion passed.

Resolution R-59-12 was read by title and summary given. R-59-12 authorizes the County Judge/Executive to execute a contract with Coverall Health-Based Cleaning System to provide general cleaning services for the Campbell County Senior Center for Fiscal Year 2013. Ms. Williams explained that staff was not happy with the performance of the current cleaning company and found that Coverall will perform the work at a lower rate. Commissioner Painter made a motion to adopt R-59-12, seconded by Commissioner Garrett. All voted "AYE" and the motion passed.

A motion was requested to accept the resignation of Emily Clayton from the part time Administrative Assistant position in the Human Resources/Assistance Program Department effective May 23, 2012. Motion was made by Judge Pendery, seconded by Commissioner Garrett. All voted "AYE" and the motion passed.

A motion was requested to appoint Amy Neeb to the part time Administrative Assistant position in the Human Resources/Assistance Program Department effective June 8, 2012 with compensation set at Grade 9O, \$20.00 per hour. Motion was made by Judge Pendery, seconded by Commissioner Garrett. Commissioner Rechtin questioned whether this is a competitive rate for this position, and was told that it was. All voted "AYE" and the motion passed.

A motion was requested to appoint James McIntosh to a seasonal Parks Maintenance Worker position effective June 11, 2012 with compensation set at \$9.91 per hour. Motion was made by Judge Pendery, seconded by Commissioner Painter. All voted "AYE" and the motion passed.

Resolution R-64-12 was read by title and summary given. R-64-12 authorizes a contract with Dental Care Plus to offer dental insurance through payroll deduction to all eligible employees of the Campbell County Fiscal Court and Detention Center. Commissioner Garrett made a motion to adopt R-64-12, seconded by Judge Pendery. All voted "AYE" and the motion passed.

Resolution R-65-12 was read by title and summary given. R-65-12 authorizes a contract with Anthem Blue Cross and Blue Shield to provide medical and life insurance plans to all eligible employees of the Campbell County Fiscal Court and Detention Center. Judge Pendery made a motion to adopt R-65-12, seconded by Commissioner Garrett. Commissioner Painter complimented Kim Serra and the other directors on getting good rates on the insurance. All voted "AYE" and the motion passed.

Resolution R-66-12 was read by title and summary given. R-66-12 authorizes a contract with Chard Snyder to serve as third party administrator of S125 Flexible Benefit Accounts through payroll deduction to all eligible employees of the Campbell County Fiscal Court and Detention

Center. Commissioner Garrett made a motion to adopt R-66-12, seconded by Judge Pendery. All voted "AYE" and the motion passed.

A motion was requested to appoint Nathan Anderson to a seasonal Park Maintenance Worker position effective June 11, 2012, with compensation set at \$9.91 per hour. Mr. Anderson is being hired to help cover for a person who is off due to a workers' compensation claim. Motion was made by Judge Pendery, seconded by Commissioner Garrett. In response to Commissioner Painter's question, Robert Horine advised that while the injured employee was off work, she was being paid by workers' compensation; she is now on light duty. The money saved by the County during the time that she was paid by workers' compensation will make up for the cost of this salary. All voted "AYE" and the motion passed.

A motion was requested to appoint Franklin Smith to a seasonal Park Maintenance Worker position effective June 11, 2012 with compensation set at \$9.91 per hour. Mr. Smith will fill a vacant position due to a resignation. Motion was made by Judge Pendery, seconded by Commissioner Painter. All voted "AYE" and the motion passed.

A motion was requested to reappoint Michael Rust to the Central Campbell Fire District Board of Trustees with a term effective July 1, 2012 through June 30, 2015. Motion was made by Judge Pendery, seconded by Commissioner Rechtin. All voted "AYE" and the motion passed.

A motion was requested to reappoint Gary McCormick to the District One Fire District Board of Trustees for a three year term effective July 1, 2012 through June 30, 2015. Motion was made by Judge Pendery, seconded by Commissioner Garrett. All voted "AYE" and the motion passed.

A motion was requested to reappoint Earl Gries to the Campbell County Fire Protection District #6 Board of Trustees with a term effective July 1, 2012 through June 30, 2015. Motion was made by Judge Pendery, seconded by Commissioner Garrett. All voted "AYE" and the motion passed.

A motion was requested to reappoint Al Strole to the Southern Campbell County Fire District Board of Trustees with a term effective July 1, 2012 through June 30, 2015. Motion was made by Judge Pendery, seconded by Commissioner Painter. All voted "AYE" and the motion passed.

A motion was requested to reappoint Michael Cooney to the Alexandria Fire District Board of Trustees with a term effective July 1, 2012 through June 30, 2015. Motion was made by Judge Pendery, seconded by Commissioner Garrett. All voted "AYE" and the motion passed.

A motion was requested to reappoint Kathy Jones to the Campbell County Extension District Board for a three year term effective June 30, 2012 through June 29, 2015. Motion was made by Judge Pendery, seconded by Commissioner Painter. All voted "AYE" and the motion passed.

A motion was requested to reappoint Judy Ihrig to the Campbell County Extension District Board for a three year term effective June 30, 2012 through June 29, 2015. Motion was made by Judge Pendery, seconded by Commissioner Garrett. All voted "AYE" and the motion passed.

Robert Horine requested a motion to meet in executive session at the end of regular business pursuant to KRS 61.810(1)(e) collective bargaining negotiations between public employers and their employees or their representatives. He advised that no action will be taken after the executive session. Motion was made by Commissioner Garrett, seconded by Judge Pendery. All voted "AYE" and the motion passed.

Steve Franzen announced that on Thursday, June 7, 2012 at 7:00 p.m. at the Campbell County Administration Building, he will hold a workshop on how to initiate a Child Support claim. He would like to present a workshop every other month to educate the public about Child Support programs.

Commissioner Painter stated that Ken Schultz, Road Supervisor, took him on a tour of County roads that are slated to be repaved. Mr. Schultz described to him how the roads are to be repaired and the expected lifespan of the pavement. He stated that many of these roads also have had slips which were repaired using FEMA funds. Mr. Schultz estimates that it would cost \$624,000 for these repairs. About \$169,000 will come from State flex funds and \$455,000 from the County's general fund. The County hasn't had a repaving program for the last three years. Commissioner Painter pointed out that the County did receive some additional revenue from the payroll of workers on the I-275 and I-471 projects and that the jail did not cost as much last year as they thought. He also stated that some underused TANK routes were discontinued which resulted in a decrease of the County's contribution to TANK. Commissioner Painter stated that road paving is one of the County's core functions and it needs to be budgeted. He stated that it would be great if the County's revenue streams were enough so that they don't have to take anything above the compensating rate. Nevertheless, the County really needs to repave some roads before they get worse and more costly.

Judge Pendery announced that the Campbell County Animal Shelter will hold an open house on June 16, 2012 to show the public the recently completed new addition to the shelter.

Judge Pendery announced that dog tags are now on sale at the Campbell County Animal Shelter and at the County Administration Building for \$5. All dogs and puppies over six months old are required to have a tag due annually on July 1st. This year citizens can print the application form from the County's website and bring or mail it in.

Judge Pendery requested a motion to change the dated of the July 4, 2012 Fiscal Court meeting to Thursday, July 5, 2012 at 7:00 p.m. at the Alexandria Courthouse, 8352 Main Street, Alexandria Kentucky. The change is requested due to the July 4th holiday. Motion was made by Judge Pendery, seconded by Commissioner Painter. All voted "AYE" and the motion passed.

Jim Seibert requested a motion to authorize staff to seek bids for the paving of the following County roads: Dodsworth, Uhl Road, Gary Lane, Clay Ridge Road and Jerry Wright Road as an alternate. Ken Schultz, Road Supervisor, recommends resurfacing of these roads. Motion was made by Commissioner Rechtin, seconded by Commissioner Painter. All voted "AYE" and the motion passed.

Resolution R-54-12 was read by title and summary given. R-54-12 adopts and approves the execution of a Municipal Aid Co-op Program Contract between the Fiscal Court of said county acting for the Unincorporated Urban Place and the Commonwealth of Kentucky, Transportation Cabinet, Department of Rural and Municipal Aid for the fiscal year beginning July 1, 2012, as provided in the Kentucky Revised Statutes and accepting all of the roads referred to therein as being urban roads which are a part of the Unincorporated Urban Place. This road aid from the Transportation Cabinet is in the amount of \$38,259.00. Commissioner Rechtin made a motion to adopt R-54-12, seconded by Judge Pendery. All voted "AYE" and the motion passed.

Resolution R-55-12 was read by title and summary given. R-55-12 renews a contract with the Kentucky Association of Counties All Lines Fund for property and liability insurance coverage effective July 1, 2012 through June 30, 2013. Mr. Seibert advised that the rate is similar to last year's even with added coverage. Commissioner Rechtin made a motion to adopt R-55-12, seconded by Commissioner Garrett. In response to Commissioner Rechtin's question, Mr. Seibert explained that the insurance broker is an agent with Roeding Insurance but works with KACo. She does get other quotes, but the market is limited for this type of insurance. Commissioner Rechtin suggested that they look into this further the next time it is up for renewal. All voted "AYE" and the motion passed.

Resolution R-56-12 was read by title and summary given. R-56-12 renews a contract with the Kentucky Association of Counties for Workers' Compensation Insurance coverage effective July 1, 2012 through June 30, 2013. The cost of coverage is comparable to last year's cost. Commissioner Rechtin made a motion to adopt R-56-12, seconded by Commissioner Painter. All voted "AYE" and the motion passed.

Resolution R-57-12 was read by title and summary given. R-57-12 approves funding for the Transit Authority of Northern Kentucky for Fiscal Year 2013. This year's funding is in the amount of \$4,059,909. Judge Pendery made a motion to adopt R-57-12, seconded by Commissioner Rechtin. Commissioner Painter stated that it was a tough decision making cuts on some underperforming routes. All voted "AYE" and the motion passed.

Resolution R-53-12 was read by title and summary given. R-53-12 grants Sheriff John Dunn Jr. his quietus for 2011 taxes. This certifies that the Sheriff has paid to the County the full amount of taxes collected. Judge Pendery made a motion to adopt R-53-12, seconded by Commissioner Rechtin. All voted "AYE" and the motion passed.

A motion was requested to approve budget transfers as presented for June 6, 2012. Motion was made by Commissioner Rechtin, seconded by Commissioner Garrett. All voted "AYE" and the motion passed.

Mr. Seibert then requested a motion to approve the claims, supplemental claims and election claims as presented for June 6, 2012. County Attorney Steve Franzen stated that he has reviewed the claims and that they all appear appropriate. Motion was made by Commissioner Garrett, seconded by Commissioner Painter. All voted "AYE" and the motion passed.

The Fiscal Court then met in executive session pursuant to motion previously made.

Motion was made by Commissioner Garrett, seconded by Judge Pendery to adjourn the executive session. All voted "AYE" and the motion passed.

There being no further business to come before the Fiscal Court, Commissioner Garrett made a motion to adjourn, seconded by Commissioner Rechtin. All voted "AYE" and the meeting adjourned at 9:30 p.m.
