## CHAPTER 71: TRAFFIC RULES

### Section

- 71.01 Maximum speed limit
- 71.02 Gross vehicle weight limit

### § 71.01 MAXIMUM SPEED LIMIT.

(A) The maximum speed limit for all vehicles, except as mentioned herein, on roads in Campbell County, shall be 35 mph unless otherwise posted by appropriate sign so designated by the Campbell County Fiscal Court.

(B) Appropriate signs shall be placed along all county roads to give notice of the maximum speed thereon.

(C) On all new and all existing subdivision roads in the unincorporated county, as adopted in the county road system, shall be posted at 20 mph and appropriate signs placed.

(D) The maximum speed limit for all school and church buses on roads in Campbell County shall be 35 mph, or the posted speed limit if less than 35 mph during the pickup phase of their route. While transporting students/passengers, no school bus or church bus shall exceed the speed of 45 mph, or the posted speed limit if less than 45 mph. For the purpose of this section, the term **PICKUP PHASE** means the period of time between the pickup of the first students/passengers and the pickup of the last students/passengers.

(E) The penalty for a violation of this section shall be a fine in an amount set forth in the schedule set forth in KRS 189.394, fines for speeding (a copy of which is attached to ordinance O-25-2000 and incorporated herein by reference.)

### § 71.02 GROSS VEHICLE WEIGHT LIMIT.

(A) No motor vehicle or other vehicle whose gross weight, including any part of the body or load, is in excess of 18,000 pounds shall be operated on a certain county road known as Pools Creek No. One, which extends from the Cold Spring City Limits, near U.S. Highway 27, and Kentucky No. 9, otherwise known as Licking Pike.

(B) Notwithstanding the provisions of division (A) above, Judge or the County Road Engineer of Campbell County, Kentucky, may, upon an application in writing by the owner or person having charge of, grant permission for the movement of vehicles, objects or structures limited by division (A) over said roadway. The permission shall be in writing, and the County Judge or the County Road Engineer may grant it subject to such conditions and restrictions as in his judgement are necessary.

(C) Any person, firm or corporation who violates the weight provisions contained herein shall be guilty of a misdemeanor, and upon conviction thereof shall be fined in an amount equal to \$.02 per pound for each pound of excess load, when the excess is 2,000 pounds or less, \$.03 per pound when the excess exceeds 2,000 pounds and is 3,000 pounds or less, and \$.05 per pound when excess exceeds 3,000 pounds and is 4,000 pounds and is 5,000 pounds or less, and \$.09 per pound when the excess exceeds 5,000 pounds but in no case to exceed \$500.00.

## CHAPTER 72: PARKING REGULATIONS

### § 72.01 PARKING NEAR FIRE HYDRANT.

No operator of a vehicle shall stop or park such vehicle at any time within 15 feet of a fire hydrant, whether said hydrant is located on a public premise or private premise.

### § 72.02 PARKING IN VIOLATION OF NO PARKING SIGNS.

(A) The County Judge Executive with the approval of the Fiscal Court is authorized to erect no parking signs in designated areas on or near any road in Campbell County.

(B) No person shall park a motor vehicle in an area where no parking signs have been erected.

(C) No person shall park a motor vehicle within one foot of the traveled portion of any road, except upon a private driveway.

(D) Any law enforcement officer may issue a citation to any person who violates division (B) or (C) above.

(E) Any motor vehicle parked in violation of division (B) or (C) above which constitutes a safety hazard may be towed away.

(F) The purpose of this section is to restrict and prohibit parking on or near the traveled portion of public roads and it is not a defense that the road is not a dedicated street, or that it is not a part of the county road system.

### § 72.03 PARKING IN FIRE LANE PROHIBITED.

(A) The shoulder alongside Union Street in California Kentucky from the railroad tracks to Madison Street on the same side as the city park, shall be deemed as a fire lane and appropriate signs shall be placed on said shoulder.

(B) It shall be unlawful for any operator of a motor vehicle to park in said fire lane.

### § 72.04 PARKING ON MALLARD DRIVE REGULATED.

(A) Parking shall be restricted on a designated segment of Mallard Drive on school days to four hours between 7:00 a.m. and 3:00 p.m.

(B) The restricted area shall span from the beginning of Mallard Drive at KY 915 and extend to Labrador Lane.

(C) The Campbell County Road Department shall mark this designated area by appropriate signage.

(D) This section shall not invalidate any other parking restrictions currently in place on Mallard Drive.

(E) Owners and/or operators of vehicles parked or left standing in this restricted parking area in violation of this section may be cited for violation of this section, punishable as set forth in § 72.99. Any vehicle parked or left standing in this restricted parking area in violation of this section may be towed at the expense of the owner and/or operator.

### § 72.99 PENALTY.

Whoever violates any provision of this chapter shall be fined not more than \$250.

(B) No person shall cause, permit, encourage, assist, or engage in the operation of a motor vehicle without first coming to a complete stop immediately prior to the intersection.

(C) Penalty for violation of this schedule shall be a fine of not less than \$20, nor more than \$100, plus court costs.
