# II. Instructions to Bidders – Terms and Conditions

The Campbell County Fiscal Court will accept bids for Resurfacing until 10:00 AM, March 26, 2021.

### A. Authority

I.

- 1. This Invitation for Bids is issued in accordance with applicable provisions of the Campbell County Administrative Code Chapter 4 Purchasing and Contracts.
- 2. This is not an order. Please read all instructions, terms, and conditions carefully.

#### **B.** Transmission

1. Bids should be submitted in a sealed envelope addressed to Campbell County Finance, 1098 Monmouth Street, Suite 322, Newport, KY 41071 via mail or third-party package delivery.

- 2. The envelope must be clearly marked with the bid title. "RESURFACING-SPRING FY 2021"
- 3. Bids will be received at the CCFC Finance department via mail or package delivery until the date specified. For public safety, we ask that you please do not hand deliver bids at this time. Please contact us at 859-547-1825 with any questions.
- 4. Late bids, those not clearly marked, or those that do not follow the instructions will not be accepted.
- 5. Campbell County Fiscal Court will not be held responsible for any premature opening or failure to open any bid not properly addressed and identified as stated above.

#### C. Instructions

- 1. Bid forms must be signed in ink.
- 2. One original and one copy of the bid must be submitted. Keep a copy of the bid for your records.
- 3. A list of qualifications and a minimum of three reference are required. Please refer to Section VII.
- 4. Bidders should verify their bids before submission. Errors in preparing the submission confers no right of withdrawal or modification after open.
- 5. Bidders are responsible for all costs associated with the preparation of response to the invitation for bids. Campbell County is not liable for any costs incurred by bidders in their response to this request.
- 6. A pre-bid or pre-award visit to bidder may be required at the discretion of the Owner.

#### D. Pricing

- 1. Firm prices are required.
- 2. All prices quoted must be F.O.B. destination shown in shipping instructions on specification.
- 3. Insert time discounts, if any. Time discounts will not be a factor in award determination.
- 4. Quotations must be submitted on the bid price sheet indicating unit price, total extension of each item, and grand total of bid.
- 5. Unit prices should be based on the bid specification instructions. Please direct questions to the County at 859-547-1825 prior to submitting a bid.
- 6. Trade discounts must be deducted by the vendor in calculating the unit price. The unit price must be net.
- 7. CCFC is KY sales and use tax exempt.

### E. Warranty

The selected Bidder shall provide warranty on any services and materials found to be defective or faulty due to imperfect or bad workmanship/materials within one year from the date of completion at no additional cost to the County. This warranty does not change or void any warranties expressed or implied to which the purchase is subject.

### F. Regulatory Compliance

1. Pursuant to the provisions of KRS 45A.343, the contractor or vendor is required to reveal to Campbell County Fiscal Court any final determination of a violation of KRS Chapters 136, 139, 141, 337, 338 and 342 by the contractor or vendor within the previous five (5) years; and further that said contractor or vendor has been and is in continuous compliance with the provisions of KRS Chapters 136, 139, 141, 337, 341, and 342 for the duration of the contract. The failure of a contractor or vendor to reveal a final determination of a violation to a local government, or to comply with the statutory requirements, is considered grounds for cancellation of a contract and disqualification of the contractor or vendor from eligibility for any Campbell County Fiscal Court contracts for a period of two (2) years.

- 2. All bidders must possess all federal, state, and local qualifications licenses to provide products or services in Campbell County, the Commonwealth of Kentucky, and the United States. Please note: Insurance requirements in Section III, Item N of the bid specifications must be met by the awarded bidder.
  - a. Including, but not limited to
    - i. Business license issued by the Occupational License Department of Campbell County (see attached application)
    - ii. Hazardous Communication Program (OSHA)
    - iii. Workers' Compensation Certificate
    - iv. Liability Insurance
    - v. Listed on current KYTC list of pre-approved bidders
- 3. Successful bidder shall comply with the Kentucky Human Rights Act, HRA 344.150-344.270 as amended and any rules and regulations promulgated therewith, including, but not limited to the Equal Employment Opportunity EEO 45.550 45.640 which is incorporated herein by reference. Furthermore, the successful bidder shall comply with the Employment Discrimination Act, EDA 344.040, 344.050 as amended.
- 4. The scoring of this bid is subject to reciprocal preference for Kentucky resident bidders. Bidders not claiming resident bidder status need not submit the corresponding affidavit.

#### G. Bonds

1. Bid bonds, performance bonds, and payment bonds as prescribed by KRS 45A.430, 435, 440 are required for any bids/proposals that exceed \$99,999. Each bid, or the combination of submitted bids, over \$99,999 must be accompanied by a 5% bid bond of the grand total of the bid. The bid bond of the successful bidder will be retained until a performance bond has been executed and approved, after which the bid bond will be returned. The successful bidder will be required to post a performance bond in the amount of 100% of the bid if awarded a contract over \$99,999. Bonding and surety requirements may vary by project/commodity. Please contact Owner for more information.

#### H. Reserved Rights

- 1. Campbell County Fiscal Court reserves the right to reject any or all bids, including without limitations the right to reject any or all nonconforming, non-responsive, incomplete, unbalanced, or conditional bids, to waive formalities, and to reject the bid of any Bidder if CCFC believes that it would not be in the best interest of Campbell County Fiscal Court to make an award to that Bidder. CCFC also reserves the right to negotiate with the apparent qualified Bidder to such an extent as may be determined by Campbell County Fiscal Court.
- 2. CCFC reserves the right of renewal for any service and maintenance contracts that may be needed for a minimum of two (2) one (1) year periods.
- 3. In the event the successful bidder fails to commence substantial work on the project within thirty (30) days and the County does not waive this requirement, the County shall have the option to reject the bid and to void the contract, and in such event to either accept the next lowest and best bidder or to negotiate with the best qualified bidder
- 4. In the event the successful bidder fails to complete the project by the completion date and the County has not waived this requirement in writing, the County shall receive from the bidder (or withhold from the bidder, at its option) liquidated damages of 1% per project per calendar day.
- 5. All the terms and conditions of these instructions to bidders and the specifications for this project shall constitute, the part of, and incorporate into, the contract between the County and the successful bidder.

# I. Award

It is the intent of Campbell County Fiscal Court to award a contract to the lowest responsible bidder meeting specifications. CCFC reserves the right to determine the lowest responsible bid/offer in any way determined to be in the best interests of Campbell County. Award will be based on the following factors (where applicable): (a) adherence to all conditions and requirements of the bid/proposal specifications; (b) price; (c) qualifications of the bidder, including past performance, financial responsibility, general reputation, experience, service capabilities, and facilities; (d) delivery or completion date; (e) product appearance, workmanship, finish, taste, feel, overall quality, and results of product testing; (f) maintenance costs and warranty provisions; and (g) repurchase or residual value.

### J. COVID-19 Bidding Procedures

- KRS 45A.365 allows for electronic posting of required bid information such as the amount of a bid and the name of the bidder. The current local, state, and federally declared public health emergency has necessitated electronic methods be used to ensure social distancing recommendations for public health.
- Bid openings will be held in an audience of three employees of the Campbell County Fiscal Court. These openings will be recorded and recordings will be available via open records request.
- 3. Bid tabulations will be posted to the County website under "Opportunities and Bids" free for public view. These results can also be requested from Laura Lewis at LLewis@campbellcounty.gov or 859-547-1825.
- Please ensure your bid documents will be received by the bid open deadline of March 26, 2021, 10:00 AM. Bid documents will only be received by US mail or third-party package delivery due to social distancing guidelines.
- 5. These guidelines have been enacted for bidder, employee and public safety according to social distancing guidelines issued at the local, state, and federal level.

#### III. Bid Specifications

- A. Site visit to all projects <u>STRONGLY</u> encouraged by bidders.
- B. All materials, equipment, construction procedures and any or all regulations that would pertain to a similar project let to contract by the Department of Transportation, Bureau of Highway or State of Kentucky shall apply to this project.
- C. All equipment (including but not limited to; road broom, grader, rollers, self-propelled paver, safety edge block, etc.) shall meet the current specifications and be approved for similar projects let to contract by the Kentucky Department of Transportation and Bureau of Highways.
- D. All cost of preparation (sweeping, cleaning, grading, tack coat, cutting key-ways at all intersections, milling of bridges, membranes, posting of project date signs and no parking signs on streets to be milled and/or resurfaced, traffic control, temporary traffic control signs, etc.) shall be incidental to the cost of the mix laid. Contractor is responsible for installing advanced warning signs prior to project in order to inform local traffic of expected start date.
- E. Contractor will provide all necessary traffic control and flagging for project. Minimum two-day notice will be provided to residential streets by contractor prior to starting project.

- F. Bituminous concrete surface and/or base estimate based on per road calculations including; road preparation, tack coat, application, placement, rolling, and flagging as measured by bidder.
- G. Each road considered its own unique project.
- H. Bituminous concrete base and bituminous concrete surface shall be based upon the current Campbell County & Municipal Planning and Zoning Commission Subdivision Regulations, Appendix B.
- I. Minimum asphalt content for asphalt base shall be 4.5% and for asphalt surface 5.5%.
- J. Tack coat shall be as per Section 406 of the 2019 Edition of the Kentucky Standard Specifications for Road and Bridge Construction. Uniform and complete coverage is expected. Tack coat must be fully cured prior to asphalt application.
- K. Key Ways to be made will be marked in white paint by county. Key ways will be made at all intersections and driveway entrances as needed. All debris from key ways WILL BE swept up and removed.
- L. Bridges If bridge is part of the project All bridges are to have key ways cut and not resurfaced unless otherwise noted. Note (1) Bridge is to be milled to top of original deck and inspected. Do not damage bridge deck. After CCRD inspection and, if needed, repair, membrane shall be installed and 1.5" of bituminous surface applied. Royston Bridge Membrane 10A Easy Pave is required and will be installed per manufacturer directions. Milled keys ways must accommodate 1.5" of applied bituminous surface. Records of Royston Bridge membrane 10A Easy Pave WILL BE provided to county as part of proof of installation. See Bid Sheet.
- M. Fabric or grid pavement reinforcement system/membrane installation maybe required, not to be confused with Item L, Bridges. Material shall be laid in place, per manufactures instructions, after leveling course is applied. Care will be taken to ensure there are no ripples or tears in the material. Additional tack coat on top of leveling course and other circumstances may be required per manufactures recommendation. See bid sheet.
- N. Milling of existing concrete pavement or asphalt as needed. SEE BID SHEET. SPECIFICATION- Areas to be milled listed on Bid Sheet. Existing pavement shall be milled at a width of 6 feet along indicated lines at a depth of 1.5 inches towards outside of roadway to ¼ inch nearest centerline (width, depth and direction changes can be made at the discretion of the Road Department). All work shall meet the latest specifications of the Kentucky Department of Highway's Standard Specifications for Bridge and Road Construction Section 408, 2019 edition. All tons to be figured in US Tons. The Contracted scope of work will include all labor, materials, equipment, and incidentals to complete the milling job, including; all flagmen, trucking and disposal of the cuttings and cleaning of milled surface and any temporary traffic control devices. County may keep some millings. Contractor will post notifications on streets to be milled. INSURANCE Contractor shall submit a "Certificate of Insurance" showing proof of Kentucky's Workmen's Compensation Insurance and Liability insurance of not less than \$500,000.00 prior to the County issuing a Purchase Order for the project.
- O. All material generated from milling and key ways will be picked up and hauled off site.

- P. Leveling/scratch course material shall be bituminous surface or base and applied with paver. Needed leveling/scratch course materials shall be approximated on Bid Sheet. Tonnage used for leveling/scratch course will be kept separate from tonnage used for resurface course. Leveling/scratch course material shall not exceed approximated tonnage without notification to Road Supervisor.
- Q. Joint Sealing specifications are dictated by Section 807 of Kentucky Standard Specifications for Road and Bridge Construction. All joints, except at driveway entrances, associated with the project, including concrete joints in curbing, will be crack sealed and price included in the cost per ton. Crack seal to be applied at intersection joints, THIS IS MANDATORY. Project is not completed until joint sealing is applied.
- R. Striping may or may not be included. See Bid Sheet. If included all striping to be completed within TWO business days or resurfacing being completed. Temporary striping to be installed as needed. Penalties incurred for striping not installed equal to project not being complete. All Striping installed per KYTC Standard Specifications for Road and Bridge Construction. Project is not completed until striping is installed.
- S. Contractor required to raise storm/sanitary sewer rings and water valve covers that are present within the project extents. Contractor is responsible for providing all rings and will have all necessary rings prior to resurfacing project.
- T. Contractor will be required to not widen the project road with the bid depth of asphalt and only install asphalt over existing asphalt unless otherwise directed by Campbell County. This will prevent asphalt edge failure do to bid depth being installed on unprepared shoulder. Asphalt surface failure along the edge of the project road which is a result of said practice will be the Contractors responsibility to repair with 8" base and 2" surface installation at point of failure plus 25' from either end for a period of six months at no cost to the County. Best asphalt construction/installation practices should be employed. Please talk to Road Supervisor for further questions.
- U. It shall be the responsibility of the contractor to include the installation of 30 degree safety edge (when asphalt, new plus old, is greater than 1.5"), paving of field entrances, road approaches, driveway entrances, milling to effect drainage etc. and perform any other duties as directed by the County.
- V. The Contractors Certified Technician shall furnish the County a report covering asphalt content and gradation for all mixes laid. Copies of all Load Tickets must be furnished. These documents shall be furnished during project and/or along with normal billing documents.
- W. Contractor shall be on the Department of Transportation, Bureau of Highways Approved and Pre-qualified bidders list.
- X. In the event of a tie, the bid with the earliest date/time received will be considered the successful bidder.

# Bridge Membrane - Royston Bridge Membrane 10A Easy Pave - Follow all manufacturers installation procedures BID NOTES



Blangey - ~575' from KY 445 to Concrete (EOCM)	Key Ways - ~575' from KY 445, 3822, 3728, 3710, 3696, 3676, 3650 (2X), 3596, 3552, Concrete at EOCM. Bridge - Mill 1.5" off of bridge, 50' x 17', and replace with 1.5" overlay. Manhole and Catch Basins (all rings/risers to be provided and installed by bidder) - One sanitary manhole to be raised at 3822, 2" HDPE adjustable ring per SD1 spec., see attached. Other upstream manholes barley touch pavement. They are to be milled around. Mill around three catch basins at end of road, 3552, and ensure new asphalt drains into the catch basins. Do not damage catch basins or sanitary manholes. Water Valves - 3 at intersection with KY 445. May have to be raised (bidder provides and installs risers), very close to key way.

#### VI. Authentication of Bid and Affidavit of Non-collusion and Non-conflict of Interest
